The prosecutors have asked if Christopher "B.G." Dorsey could hand over the lyrics to his music as part of his probation

In response to our request for comment, Dorsey's attorney said this quote "We are looking forward to appearing with Mr. Dorsey in New Orleans and addressing the important legal issues before the court"

The rapper says the rules are impacting his freedom of speech
